152) Chairman's Report from Cllr Jones

Welcome Councillors to February's Full Parish Council Meeting.

Firstly, the Radio Wing meeting at Locking Parklands that I had been invited to attend on 23 January 2025 was cancelled by Mr Chris Hart of St Modwen. I am led to understand that it will be rescheduled for later this month, hopefully with other CIC members being invited.

On 5 February 2025 ten trees supplied by North Somerset Council were planted on the southern boundary of the playing field at Old Banwell Road. The trees are a mixture of UK native trees, and will assist in reducing water run-off, helping to filter wind and eventually provide some shade. The planted trees are standard sized trees, more trees will be forthcoming in the near future, kindly provided and funded by North Somerset Council. Further works at the Tiny Trees area have recently been conducted with the installation of benches and signage, the area really looks user friendly and welcoming.

On 6^{th} March 2025 Locking Parish Council are organising the planting of a further 11 various fruit trees at the Orchard at Old Banwell Road. Locking Primary School have again volunteered to assist in the planting. As many of you may recall the last time, we conducted this type of exercise the involvement of the children made it very rewarding and good fun for all attending. It is proposed to start the planting at 2 pm finishing about 3 pm on the 6^{th} of March however it has been suggested that we might prepare the ground prior to that date, possibly on the $1^{st} - 3^{rd}$ March 2025. The exact date and time to be agreed by much-needed volunteers.

I am very pleased to state that we have received positive feedback from users of the Nurse Thomas Suite who had booked the room for training purposes. Apparently, it met all their expectations and more. Hopefully they will back.

154) Cllr Porter reported the following:

 Planning application 24/P/2334/FUL Skatepark submitted by Locking Parish Council – Cllr Porter and Cllr Solomon continued to support the Parish Council with regards to this application and acknowledged that LPC had answered and resolved objections submitted by Sport England that they would call this planning application to the Planning Committee for decision.

 North Somerset Local Plan – additional site consultation will take place between 7 February and 21 March 2025. Three drop-in events at Weston, Long Ashton and Nailsea/Backwell would be held. Cllr Porter had not been advised or yet briefed of the actual dates or locations for the dropin sessions or the vague colour key description meant on the Strategic Housing Land Availability Assessment map (SHLAA). Cllr Porter stated he would come back to us when he had been briefed.

 MacDonalds planning application at Weston Business Park – no updates regarding this planning application.

Flooding Working Group: raised flooding issues within Locking Village – Cllr Porter advised he
would be happy to engage with the working group.

Returned to Standing Orders at 20.10hrs - Cllr Porter left the meeting.

- 155) Tiny Forest Land Agreement: To sign off the Agreement which sets out the obligations and responsibilities of each of the three parties involved Earthwatch (Deliverables), North Somerset Council (Funding), Locking Parish Council (Participating Authority). It was RESOLVED that the Clerk be authorised to sign the Agreement on behalf of Locking Parish Council unanimously AGREED.
- **156) Precept Request for 2025/26:** Confirmation that the Precept Request had been accepted by North Somerset Council. **Noted**
- **157) Mendip Rise Locking prevent abuse of the No Entry at the southern junction.** To receive North Somerset Council's response to the serious road safety issues raised by this Council Min Ref: LPC120c refers.

North Somerset Council Transport Policy Team had advised that the one-way scheme had failed the Stage 2 Policy Check receiving only 25% within the total match with their strategic priorities framework. LPC were reminded that a TRO was in force to restrict access (No Entry). If vehicles were ignoring the signage the primary course of action should be enforcement which was within the jurisdiction of the police. The issue had been reported to NSC Road Safety Team who would monitor the impacts of the original scheme and TRO.

Cllr Terry Porter had taken the above to Head of Highway Technical Services at NSC who advised the bollards had been removed as they had become a 'maintenance issue', along with that there is no accident history at the location and given the low scoring of this highway improvement in comparison to other locations this would not be a priority for funding. Unless LPC are willing to fund a permanent scheme it would be unlikely that NSC would be able to justify further works here.

Cllr Porter was to look into whether the Parish Council would be allowed to put a type of planter on the hatchings at the top of Mendip Rise – Clerk to chase this up with Cllr Porter.

Members discussed the above and as NSC were the principal authority for road safety and had a duty of care for safety members agreed that the Clerk write to the Head of Highway Technical Services. It was also agreed that the Clerk put an article into Looking @ Locking advising that should residents witness a breach of the one-way system to send photographic evidence along with date/time, make/model of vehicle to the NSC Road Safety team and the Police.

The Clerk to look up legislation for the power to contribute to road safety schemes.

158) Legal Position on Contributions for Public Rights of Way Services - See Min Ref: LPC 127:

- a) New information received: Legal advice had been received from ALCA regarding contributions to the statutory service provided by North Somerset Council.
 Given the new information received it was RESOLVED that Min Ref LPC 127 be rescinded. Unanimously AGREED.
- b) To receive North Somerset Councils recent advice regarding contributions to the PROW Service. **Noted.**
- **159) Flooding Working Group:** Report from the Working Group had been previously circulated (copy available from the Clerk)

Members **AGREED** that an onsite meeting with Tom Hatfield Engineer NSC would be productive with the following to be discussed:

- The triangular drain covers outside 92 and 98 Elm Tree Road. Are sealed manhole covers and
 we feel the cover could be replaced with an open (gridded) style covers to reduce the need for
 residents to lift covers and reduce the health and safety risk. AGREED to investigate further
 regarding cost of replacing with open grates and look into legislation for the power to spend
 funds.
- The gulley opposite 90 Elm Tree has a small pipe running from it plan attached. If this was
 connected with the opposite side of the road this would also assist as this is the area of roadway
 that first starts to flood.
- With regards to Mendip Rise to ask NSC to obtain a cost for the pipe work to be investigated.
- The Clerk to look into legislation for the power to spend funds. price up. Perhaps via aqua blast to have the pipe work investigated. Perhaps LPC would like to contribute.
